Maritime community explores ocean opportunities in Dubai

World Maritime Day Parallel Event focuses on advancing innovation and growth while protecting the ocean.

Dubai, in the United Arab Emirates, was the stage to exchange ideas, showcase innovation and strengthen international cooperation during the celebration of the 2025 World Maritime Day Parallel Event (WMDPE) this week.

The event (30 September – 1 October) was hosted by the United Arab Emirates Ministry of Energy and Infrastructure in collaboration with the International Maritime Organization (IMO).

Welcoming delegates, the Minister of Energy and Infrastructure, H.E Suhail bin Mohamed Al Mazrouei, said: "This gathering gives us an opportunity to unite our efforts toward achieving that balance of economic growth with protecting the oceans which connect us together and keeping them healthy for the next generation."

Global maritime community celebrates "Our Ocean, Our Obligation, Our Opportunity".

The international shipping industry, which carries over 80% of global trade and uses more ocean space than any other sector, is stepping up action to protect the ocean.

This year's World Maritime Day, observed globally on 25 September, focuses on the sector's impact on the marine environment, and what it can do to reduce pollution, curb greenhouse gas emissions and prevent biodiversity loss.

Secretary-General of the International Maritime Organization Mr. Arsenio Dominguez said:
